The Basel Area is Europe's most successful life sciences cluster - a thriving life sciences innovation hub at the heart of Europe. Home to over 800 life sciences companies and more than 1,000 research groups, it boasts an unrivalled life sciences talent pool with 33,000 well-qualified employees in the region, compared to the Geneva region with 8,500 and the Zurich region with 11,300.

The region has a very high density of successful life sciences companies such as global giants Novartis and Roche and other worldwide players like Lonza, Moderna, Abbott, Johnson & Johnson, Bayer, Boehringer Ingelheim and Syngenta. But it is not just about big pharma, one also finds many up-and-coming mid-sized biopharma companies like Idorsia, Anaveon, Basilea, BeiGene, NBE Therapeutics, Nouscom, Galapagos, Myovant, Skyhawk Therapeutics, T3 Pharmaceuticals, Alentis Therapeutics, Vectiv Bio, Autolus, LifeMine Therapeutics, Noema Pharma, WORG Pharmaceuticals, Tenpoint and many others. Numerous small and medium-sized companies and a large number of successful startups and spin-offs enrich the integrated life sciences landscape.

Biotechnology, healthcare, pharmaceuticals, medtech, healthtech, chemistry and agricultural sciences, together with complementary technologies such as nanoscience and bioinformatics – the Basel Area fulfills all the conditions necessary for a top life sciences cluster. Alongside the pharmaceutical, biotechnology and medical technology companies, the other sectors in the region also benefit from the dynamism generated by the life sciences cluster.

In particular, ICT companies collaborate with biotech startups, medium-size companies or big pharma to innovate and bring better medicines to patients faster. Furthermore, the promising healthtech sector is growing fast which makes the Basel Area the location where the future of healthcare is taking place. The region is leading the healthcare transformation.

Local initiatives like DayOne connect the industry with academia, healthcare providers and government to drive innovation and accelerate startups. Innovators develop clinical decision support technologies, patient applications, precision medicine and diagnostics, or optimize the healthcare system. This community has already grown to over 4,000 healthcare innovators.

BaseLaunch is an accelerator and incubator that helps scientists and entrepreneurs to launch exceptional biotech companies. It helps build companies from inception through to Series A funding, by providing financing of up to \$500,000 per venture and supporting all aspects of business development. BaseLaunch partners with Roche, Pureos Bioventures, Novo Nordisk, Roivant Sciences, Bridge Bioventures, CSL Behring, Johnson & Johnson and CMS China Medical System. Since 2018, BaseLaunch has supported 24 ventures and 9 of the portfolio companies have raised in total over \$800 million with an average first VC round of over \$28 million per company. Making Baselaunch one of the leading incubators in Europe.
